Terms and Conditions

Prize Draw Terms and Conditions

By entering the free prize draw to win the FitBit (the “Prize Draw”), you agree to be bound by these terms and conditions. Please read them carefully.

Promoter

1. The promoter of the Prize Draw is WaterAid (Charity no 288701) WaterAid, 6th Floor, 20 Canada Square, Canary Wharf, London E14 5NN(“WaterAid”)
2. Entry requirements
3. Participants must be at least 18 years old to enter and legally resident in the UK, excluding Northern Ireland.
4. Employees or contractors of WaterAid and their immediate families and members of households, and anyone else connected in any way with the Prize Draw are not eligible to take part.
5. WaterAid reserves the right to require any participant to prove that he or she meets the entry requirements in these Terms and Conditions and is eligible to participate in the Prize Draw.

How to Enter

1. The Prize Draw will open at 9.00am on 18 January 2021. The Prize Draw will close at 11:59pm on 22 March 2021. After this time no further entries to the Prize Draw will be permitted.
2. No purchase or donation to WaterAid is necessary to enter the Prize Draw.

Prize on Offer

2. The prize is non-transferable. WaterAid reserves the right to substitute the prize for a prize of equivalent or greater value, or at WaterAid's sole discretion, the cash value of the prize, if this is necessary for reasons beyond WaterAid's reasonable control.
3. The prize includes costs to deliver the prize to an address in the UK.

How the winners will be chosen.

1. The winners of the Prize Draw will be drawn at random by computer from all complete, eligible, properly submitted entries received before the closing date and time. The draw will take place within three working days of the closing date.
2. The winner will be notified within 10 working days of the draw using the email address provided on the entry form.
3. In the event that contact with a winner cannot be made within 15 working days of the draw date or the winner is found not to meet the entry requirements in these Terms and Conditions, WaterAid reserves the right to withdraw the prize entitlement and to award the prize to another participant who will be drawn at random by computer.

Publicity and Data Protection



1. By entering the Prize Draw, participants agree to have their name, county and photograph featured in reasonable publicity relating to the Prize Draw without further reference, payment or other compensation.
2. For 14 days from the closing date of the Prize Draw, details of the winner will be made available to participants and the public on request by sending a letter and stamped addressed envelope to Just Water Team, WaterAid, 6th Floor, 20 Canada Square, Canary Wharf, London E14 5NN.
3. WaterAid will collect and process participants' personal information in order to conduct the Prize Draw and this information will be shared with WaterAid's agents to the extent necessary for the Prize draw to be administered and the prize to be delivered to the winner.

WaterAid reserves the right to modify, cancel, terminate or suspend the Prize Draw in whole or in part, at its sole discretion, if it believes the Prize Draw is not capable of being conducted as specified within these Terms and Conditions or in the event of any other cause that is beyond the reasonable control of WaterAid that could affect the normal course of the Prize Draw.

Neither WaterAid nor any of its subsidiary or affiliated companies are responsible for any losses, failures or delays caused by events beyond its or their control such as (but not limited to) the acts or defaults of any supplier selected by WaterAid to provide the prize that may lead to loss or damage of the prize in transit to the winner.
